# **World Press Freedom Day 2015**

"Let Journalism Thrive! Towards Better Reporting, Gender Equality, & Media Safety in the Digital Age"

In 1993, the UN General Assembly proclaimed 3 May as World Press Freedom Day following a Recommendation adopted at the twenty-sixth session of UNESCO's General Conference in 1991. It serves as an occasion to inform citizens of the violations of press freedom- a reminder that in dozens of countries around the world publications and online and social media are censored, fined, suspended and closed down, while journalists, editors and publishers are harassed, attacked and even murdered.

World Press Freedom Day is a date to encourage and develop initiatives in favour of press freedom and a day of reflection among media professionals. Three inter-related issues will be explored in the 2015 global theme, "Let Journalism Thrive! Towards Better Reporting, Gender Equality, & Media Safety in the Digital Age." The opening session will provide a global perspective while the panel discussion will focus on the safety of journalists, specifically on digital security, the security of women journalists and freelancers, with an emphasis on ideas and best practices that can result in real change.
